FINANCIAL DATA SHEET for DAY STUDENTS (2016-17)

TUITION: The tuition for the 2016-17 academic year is **\$6,740.00*** per student.

TUITION PAYMENTS: The three tuition payment plans offered by Saint Stanislaus (SSC) are:

Saint Stanislaus offers you the opportunity to budget education expenses over a period of months; however, Saint Stanislaus encourages you to pay for your son's education using the annual or semester payment plans that offer prepayment discounts. To receive the yearly or semester discount, payment must be made in full within five days of the due date. Moreover, the following year's Re-Registration Fee is also due in February. **SSC accepts cash, check, automatic draft, VISA, MasterCard, and Discover Card to pay tuition and fees for the 2016-17 school year. There is a 2.44% service charge to process credit card payments.**

LATE ENROLLMENT: If your son is enrolled after the first day of school, the yearly tuition costs will be calculated on a per diem basis (**\$6,740.00/180 school days = \$37.44 per school day**). If your son is enrolled prior to the twentieth (20th) of the month, payment for the remaining school days in the month is required prior his arrival date. If he is enrolled on or after the twentieth (20th) of the month, payment for the remaining school days in the month and payment for the following month are required prior your son's arrival date.

APPLICATION FEE: A NON-REFUNDABLE Application Fee of \$100 is required with all applications for enrollment. If your son is accepted and enrolled at Saint Stanislaus, this Application Fee is applied to the Registration Fee.

REGISTRATION FEE: Upon approval for admission, a NON-REFUNDABLE Registration Fee is required for all students enrolling at Saint Stanislaus. The Registration Fee reserves a place for your son at Saint Stanislaus. The following schedule applies to the Registration Fee for the 2016-2017 school year:

If payment is received:	On or before February 26, 2016	\$250.00
	After February 26, 2016	\$350.00

SPECIAL FEES: The only other fees that may be due are:

1. ACADEMIC ASSISTANCE FEE (8 monthly payments of \$162.50 due September - April)	\$1,300.00
2. SENIOR FEE (Graduation and Retreat due on February 5, 2017)	\$225.00
3. 8th GRADE PROMOTION FEE (due on February 5, 2017)	\$65.00
4. TUITION LATE FEE assessed on the 10 th of each month	\$25.00
5. EARLY WITHDRAWAL FEE (10 days @ \$37.44 = \$374.40)	\$374.40

NOTE: Day Students are **NOT** allowed to charge on their student accounts.

*Tuition includes \$50 standardized test preparation fee that will provide students with a series of test prep resources, an official ACT test for juniors and seniors, practice ACT tests and feedback for all other grade levels, and additional PSAT prep.

DAY STUDENT TUITION COLLECTION POLICY (2016-17)

DUE DATES FOR PAYMENTS:

Yearly Payment: due August 5, 2016

Semester Payments: due August 5, 2016 and December 5, 2016

Monthly Payments: due the 5th of each month, July through April

BEGINNING OF SCHOOL: Before a student is allowed to begin school in August, both the July and August payments must be paid if tuition is being paid each month. The full yearly payment or the first semester payment must be paid by August 5, 2016 if tuition is being paid on the yearly or semester plan.

STATEMENTS: Monthly statements are **emailed** ten (10) days prior to the payment due dates (approximately the 26th of each month). Tuition for day students is due on the 5th of each month. Please ensure you have a valid email address on file. Monthly statements will be mailed by **request only**.

PAST DUE PAYMENTS: Five (5) days after the payment on a student's account is due and not paid in full (i.e. on the 10th of the month), the account becomes "Past Due" and a late tuition fee of \$25 will be assessed each month the account is in arrears. If payment is not made by the 15th of the month, the student may be asked to remain home on the following Monday until payment is made in full and PowerSchool privileges will be discontinued until the account is no longer in arrears.

QUARTER AND SEMESTER EXAMINATIONS: An exception to the above may occur when quarter and semester examinations are involved; namely, parents of the students whose tuition accounts are in arrears will be notified prior to the start of examinations that their son is to remain home until payment is made in full. Delinquent payments that are made immediately prior to examinations must be by cash, cashier's check, or money order.

COMMUNICATION BY PARENTS: It is the responsibility of the parents to contact the President of Saint Stanislaus should extenuating circumstances necessitate a temporary adjustment in payments. Such communication must take place prior to, rather than after, written communications from the school.

METHODS OF PAYMENT: SSC will accept cash, check, automatic draft, VISA, MasterCard, and Discover Card to pay tuition and fees for the 2016-17 school year. There is a 2.44% service charge to process credit card payments.

CHECKS: Checks returned to the school by the bank as "NSF Checks" will be deposited a second time. A \$25 "NSF Assessment" is charged to the parents' account. Should an "NSF Check" not clear the second time, parents will be informed that payment must be made by cash, cashier's check, or money order.

RECURRING PROBLEMS: If a pattern of "NSF Checks" develops, parents will be notified that all future payments must be made by cash, cashier's check, credit card, or money order.

STUDENT DEPARTURES: Should a Day Student withdraw or be dismissed for any reason, a 10 day penalty of **\$374.40** ($\$6,740.00/180 = \37.44 per day x 10) will be assessed.

COLLECTION COST: Parent(s)/Guardian(s) are liable for any collection or legal fees incurred by the school to collect delinquent accounts.
