FINANCIAL POLICIES for DAY STUDENTS 2018-2019

TUITION: The tuition for the 2018-19 school year is \$7,670.00* per student.

DUE DATES FOR PAYMENTS: Yearly Payment: due August 6, 2018
Semester Payments: due August 6, 2018, and January 7, 2019
Monthly Payments: due each month, July through May

THREE TUITION PAYMENT OPTIONS:

Annual by August 6	Semi-annual by August 6 and January 7	Monthly 11 months – July – May

*The annual plan offers a prepayment discount of \$200.00. To receive the yearly discount, payment must be made **in full** by August 6.

Please note that each of the three payment plans being offered for next year's tuition include the Senior Fee or the Re-registration Fee for the following year.

FOR NEW STUDENTS:

APPLICATION FEE: A NON-REFUNDABLE Application Fee of \$100 is required with all applications for enrollment. If your son is accepted and enrolled at Saint Stanislaus, this Application Fee is applied to the Registration Fee.

NEW STUDENT REGISTRATION FEE: Upon approval for admission, a NON-REFUNDABLE Registration Fee is required for all new students enrolling at Saint Stanislaus. The Registration Fee reserves a place for your son at Saint Stanislaus. If the new student registration fee is received on or before Friday, March 30, 2018, it is \$250.00. If it is received after Friday, March 30, 2018, it is \$400.00.

FOR RETURNING STUDENTS:

RE-REGISTRATION FEE: The NON-REFUNDABLE Re-Registration Fee of \$250.00 has already been paid through your FACTS account. If re-registration forms are not returned by the due date of March 1, 2018, a \$150.00 late fee will be applied.

METHOD OF PAYMENT FOR TUITION AND FEES: All families are required to enroll in the FACTS Tuition Management Program.

FOR NEW STUDENTS:

The enrollment period begins March 1, 2018, and enrollment must be completed by June 1, 2018. The FACTS website is <https://online.factsmgt.com/signin/3W66K>. For your convenience, a link is on the ststan.com home page.

FOR RETURNING STUDENTS:

FACTS will automatically re-enroll your son for the 2018-19 school year. Please be sure to make any necessary changes to your FACTS account, i.e. banking, credit card, email, mailing address.

SPECIAL FEES:

1. **ACADEMIC ASSISTANCE FEE** (billed based on tuition payment option chosen) \$1,500.00
2. **8th GRADE PROMOTION FEE** (billed in September) \$65.00

DELINQUENT TUITION: FACTS Tuition Management Program will notify SSC that an account is in arrears. SSC reserves the right to suspend a student from school until tuition is up to date. Students with indebtedness to the school are not eligible for exams or graduation.

COMMUNICATION BY PARENTS: It is the responsibility of the parents to contact the President or Finance Director of Saint Stanislaus should extenuating circumstances necessitate a temporary adjustment in payments. Such communication must take place before an account becomes delinquent.

LATE ENROLLMENT: If your son is enrolled after the first day of school, the yearly tuition will be calculated on a per diem basis ($\$7,670.00/180$ school days = \$42.61 per school day). When you have set up your account through the FACTS Tuition Management Program, your monthly tuition will be calculated according to this formula.

EARLY DEPARTURE: Should a day student withdraw or be dismissed for any reason, a 10 day penalty of \$426.10 will be assessed.

CHECKS: There is a \$50.00 NSF fee for any payments made directly to SSC by check (such as for lunch, field trips, bookstore and the like) that are returned to the school by the bank as "NSF."
